I. Call to Order

The Chair called the meeting to order at 6:00 p.m.

II. Invocation and Pledge of Allegiance

Board Member Ms. Gloria Menyweather-Woods asked everyone to join her in the Invocation and Pledge of Allegiance to the United States flag.

III. Approval of Agenda

V. Approval of Minutes

Regularly Scheduled Meeting – October 9, 2018

VII. New Business

A. KASS Update

The IDA Chair said the Town of Lawrenceville is accepting bids to have the building that KASS will be occupying painted. He said the equipment for KASS is ready for shipment from overseas and will take approximately 25 days to deliver.

B. Property Update

The Chair said the IDA recently purchased approximately 418 acres of land that is adjacent to the former Saint Paul's College campus and property located at 315 North Main Street previously owned by Dr. Elton Brown. He said the IDA is actively marketing both properties and several prospects have expressed an interest in the properties.

C. Contractors/Builders

The Chair said the IDA plans to advertise for bids from qualified contractors to provide prices on a cost plus percentage basis for general maintenance, plumbing and electrical repairs.

D. Intern Program Update

Ms. Jeannell Jones, Finance/Project Manager is meeting with the Principal and two Guidance Counselors from Brunswick High School in December to discuss plans to have two interns at the IDA and they will focus on marketing and other IDA project related activities.

E. Public Use of IDA Conference Room

Board Member Mr. Bill Hudson said he received a request from a Boy Scouts Troop to use the conference room at the IDA as was done many years ago. Melissa Boucher, IDA Office Manager, said the former Executive Director stopped allowing groups to use the conference room due to the large volume of confidential information in the office. The Board agreed to keep the former Executive Director's policy on use of the IDA conference room in place.

VIII. Old Business

A. Non-Disclosure Agreement

The IDA Chair said he asked the IDA Attorney to prepare a more simplified Non-Disclosure agreement for Board members, staff and other key personnel to sign as the previous agreement presented was too complex. The IDA Attorney said she needed to correct the formatting on the first page of the Non-Disclosure agreement and would submit the document to the IDA Office Manager for distribution prior to the next meeting.

IX. Chairman's Report

The Chair said the IDA is leading the way to bring a YMCA to Brunswick County. He said a steering committee has been formed and community interviews have taken place. He also said that it has been suggested that a consultant be hired to look at ways Brunswick County can raise the \$300,000 to \$500,000 needed to move the YMCA project forward.

He said the IDA continues to work closely with the Town of Lawrenceville and County Officials to seek ways to attract businesses to Brunswick County.

This concluded the Chair's report.

X. Committee Reports

- **A. Personnel** The IDA Chair asked Mr. Ray Thomas and Ms. Gloria-Menyweather Woods to serve on the Personnel Committee and they both agreed to serve on the Personnel Committee.

- C. Property Board Member Mr. Bill Hudson said "For Lease" signs have been ordered from Extreme Signs to place in buildings the IDA recently purchased. He suggested that the Property Committee meet to develop a plan for the leasing of properties the IDA has purchased. Mr. Hudson said he has received one bid on trimming trees and repairing lights at the Brunswick Industrial Park and another bid is expected. He also said the telescoping flagpole is not staying up at the Brunswick Industrial Park and he asked Frank Arthur, the contractor who installed the pole, to make the necessary repair. Mr. Hudson recommended that the IDA purchase several For Sale signs and place them on the small tract of land in front of the prison that the IDA owns. He went on to say that he purchased a 12-foot cattle gate to be placed at the entrance of the land the IDA recently purchased. The Chair thanked Mr. Hudson for his property report.

The Chair reminded everyone that the Lawrenceville Christmas Parade is December 7, 2018 and the IDA staff will be serving cookies and hot chocolate prior to the start of the parade.
