I. Call to Order

The Chair called the meeting to order at 6:00 p.m.

II. Invocation and Pledge of Allegiance

Board Member Mr. Bill Hudson asked everyone to stand and join him in the Invocation and Pledge of Allegiance to the United States flag.

III. Approval of Agenda

The Chair requested that Item "VII. New Business:" O. Roof Repair at Dr. Ackerman's Office be placed on the Agenda

Motion: Mr. Bill Hudson moved, seconded by Mr. William Brown to approve the agenda with the addition as requested.

Upon vote of those present, the motion was unanimously carried.

The Chair noted that at last month's IDA Board meeting he did not allow Ex-Officio Mr. Buck Brockwell to view a document. The Chair said he was in the wrong for not allowing an Ex-Officio to view the document and wanted the minutes to reflect his apology to Ex-Officio Mr. Buck Brockwell.

IV. Citizens Comments

Mr. Phil Gilson provided an update on his glass blowing and seamstress business located on Brickyard Street in Lawrenceville, Va. He said they have several events planned in the near future that will provide their business with international coverage. Mr. Gilson distributed to everyone a copy of Early American Life magazine and he is listed in their directory of traditional American crafts as Colonial American period-style glass blowing. The IDA Chair thanked Mr. Gilson for his update and asked him to schedule a time to meet and discuss ways to further establish his business in Brunswick County.

A. Seeding/Brunswick Industrial Parks

Motion: Mr. Ray Thomas moved, seconded by Ms. Gloria Menyweather-Woods to submit separate Request for Proposals (RFP) for grass cutting and re-seeding at the Brunswick Industrial Park and the I-85 Business Park.

Upon vote of those present, the motion was unanimously carried.

The IDA Chair said trailers were being parked and left unattended at the Brunswick Industrial Park and this problem needs to be addressed by the Board.

B. Communications Log

The IDA Chair informed Board members that a communications log is being kept in the IDA office for everyone to review. He said the purpose of the log is to be transparent in the operations of the IDA. He also said the communications log contains copies of all documents that he signs as well as emails related to the day to day operations of the IDA office.

C. Audit of Properties Progress Report

Board Members Mr. William Brown and Mr. Bill Hudson recently visited each of the Industrial Parks and provided an update on issues that need to be addressed such as landscaping at each entrance to the Parks. He also recommended placing a flag pole with the American flag at each entrance. He distributed booklets containing information and photos of the Parks to Board members for their review.

D. Funding of IDA

The County did not appropriate any operational or capital funding to the IDA for Fiscal Years 2018 and Fiscal Year 2019.

E. 2nd Board Meeting During Month

The IDA Chair said he was not suggesting a second monthly IDA Board meeting each month but said the IDA conference room was available for Committees to use if they needed to meet and discuss items.

F. IDA By-Laws Committee
