I. Call to Order

The Chair called the meeting to order at 6:00 p.m.

II. Invocation and Pledge of Allegiance

Ex-Officio Mr. Buck Brockwell said the recent video produced about Brunswick County was impressive. He also said several people had mentioned to him that the Brunswick County website looked great and was very user friendly.

Board Member Mr. Ray Thomas moved, seconded by Mr. Bill Hudson that Board Member Mr. Mike Dotti be re-elected to serve as Chair of the Brunswick County Industrial Development Authority.

The Chair said the engineering firm of Jeff Robinson & Associates is preparing a structure analysis of the IDA office building for the renovation of the second and third floors.

The Chair said bush hogging at both of the Industrial Parks has been completed and entrance landscaping at both parks has begun. He said Justin Robinson recently took drone photography of both parks and that photography is on the IDA website and will be used in future marketing of the parks to attract industry. He also said he plans to meet with the Director of Social Services to make an assessment of what repairs are needed at the Department of Social Services building. He also said the IDA continues to work closely with the Town of Lawrenceville to discuss improvements to the appearance of downtown. He said the DEQ cited a small violation on the North Water System that the IDA owns in their annual water test report.
