#### VII. New Business

#### A. Meherrin River Water Renewal Update/KASS Update

Mr. Bob Roop with the Timmons Group provided an update to IDA Board members on the Meherrin River Water Supply Renewal Permit process. He said the Meherrin River Water Renewal Permit was submitted on February 15, 2018. He also said the USACOE requested that a water plant treatment site be added to the permit. He went on to say that he expects the permit to be issued in about 90 days with a 30-day public notification period. The tiered permit based on actual demand is valid for 15 years and will allow for 6 MGD average annual withdrawal from the Meherrin River.

Dr. Charlette T. Woolridge, County Administrator, provided an update on the KASS project. The business will be located in the former Southern States building at 409 West Fifth Avenue owned by the Town of Lawrenceville. Dr. Woolridge said KASS Foods focuses on manufacturing healthy snack products in various segments including organic, sweet and savory. She said the project is a partnership between Ajay and Kareena Sujanami, owners, the Brunswick County Industrial Development Authority, Town of Lawrenceville, County of Brunswick, Virginia Tobacco Region Revitalization Commission, Virginia's Growth Alliance, Virginia Department of Housing and Community Development and Southside Planning District Commission. She said the project is moving forward on time and a ribbon cutting will be scheduled in the near future. The IDA Chair thanked Dr. Woolridge for providing a summary of the project.

The IDA Chair said a letter was mailed to the Brunswick County Board of Supervisors in regards to IDA Board Member Henry Robinson and his failure to attend monthly Board meetings or participate in IDA functions. A second letter was also to the Board of Supervisors requesting that the IDA be added to the Board of Supervisors monthly board meeting Agenda in order to provide updates.

## IX. Chairman's Report

The IDA Chair the interest meeting to bring a YMCA to Brunswick County was held at the Brunswick County Conference Center recently and there was a very successful turnout of citizens interested in making this possible. He said the Project Manager is working to update site inventory on the VEDP website. He said she is also doing the framework to identify all commercial, industrial and agricultural properties in Brunswick County including the three Towns. Mr. Dotti said another project is identifying vacant properties throughout the County. He went on to say that a letter to all business owners in Brunswick County is being planned. He also said the annual audit of the IDA's finance was recently conducted in the IDA office by the firm of Robinson, Farmer, Fox, Associates. He thanked the office staff for their work on the many projects currently underway at the IDA and thanked Board Members for their active roles on various issues.
