#### I. Call to Order

The Chair called the meeting to order at 6:00 p.m.

# II. Invocation and Pledge of Allegiance

The Chair asked the Business Director to begin the meeting with the Invocation and asked everyone to join him in the Pledge of Allegiance to the United States flag.

\*\* At this time the Business Director introduced Board Member Ms. Alfreda Jarrett Reynolds representing the Totaro District to the IDA Board. Ms. Reynolds replaces Board Member Mr. Bill Hudson who has not been able to fulfil Board member responsibilities due to health reasons.

# III. Approval of Agenda

## VII. New Business

#### A. Lawrenceville Video

The Business Director said HGTV is having a contest to select a town in the United States for a town makeover. He said members of the community got together and produced a video of downtown Lawrenceville to be entered in the contest. He went on to say that the video can be viewed on the IDA website.

## B. Movie Night

The Business Director said movie night at the Brunswick County Conference Center will be returning in June and children's movies will be shown free of charge. He said movie night is funded by community donations and there is approximately \$600.00 left over from last year's movie nights. He said he was requesting a Motion from the Board to allow the IDA to manage the finances for movie night.

**Motion:** Ms. Arnika Green moved, seconded by Mr. Will Ford to allow the IDA to manage the finances for community movie night at the Brunswick County Conference Center during the summer months.

Upon vote of those present the motion was unanimously carried.

## C. Elton Brown Estimates

The Business Director said the IDA has a signed lease for the former Elton Brown building. He said a cardiologist will be moving into the lower floor once renovation is completed. He said all permits have been obtained and renovation of the building is progressing according to schedule.

#### D. Barbecue Festival

The Business Director said a "BBQ On The Runway" event is scheduled for August 22, 2020 at the Brunswick Airport. He requested that the Board consider sponsoring the event at the \$5,000 Smoker/Platinum level. Dr. Seward said the BBQ festival will be similar to the Virginia Pork Festival held in Emporia in past years. He said civic organizations, churches, fire departments and the area school systems will all benefit from the event. He went on to say that 3,000 tickets will be sold and the event fits the tourism vision for the County. The IDA Chair requested that a motion to sponsor the event be tabled untiled the next IDA monthly Board meeting.

#### VIII. Old Business

# A. Budget time to set up meeting

The Business Director said he would like to schedule a meeting with the Chair and Vice-Chair to review and make any necessary changes to the budget for Fiscal Year 2020-2021 prior to the next IDA monthly Board meeting.

## B. Financial Disclosure Forms – Due February 3, 2020 did you do one

The Business Director reminded Board members that Financial Disclosure forms need to be completed by February 3, 2020. He said a fine of \$250 may be imposed if the deadline is not met.

## C. Historic District Update

The Business Director said the IDA is working closely with the Town of Lawrenceville to update historic district buildings within the Town of Lawrenceville.

## D. Alberta and Brodnax Outreach

Discussions are underway with officials from the Town of Alberta and Town of Brodnax on ways the IDA can assist in revitalizing both towns.

## E. Pop's Update

IDA Consultant Mr. Mike Byrne said Mr. Chuck Lessin and his family are planning to open Pop's Bar & Grill in Lawrenceville in late Spring. He said all necessary permits have been obtained and demolition has been completed. He also said a lot of the restaurant equipment to be used was purchased at auctions. He also said that a lot of money has been saved by not having to use a third party for the purchasing of equipment due to the previous restaurant experience of the Business Director and himself. He said the process has begun to begin searching for managers and staff to run the restaurant. He went on to say that some of the food preparation will be done in Richmond and brought to the Lawrenceville location while other menu items will be prepared at the location. Opening date has not been set but Mr. Lessin is aiming for a late Spring announcement.

# IX. Directors Report

#### **Echo World:**

The Business Director said adequate staffing is delaying the opening of the digital health care system in the former Bank of America building in Lawrenceville.

## KASS, USA

The Business Director said the IDA is disappointed in the performance of KASS, USA and the IDA is working with the owners to determine the next steps to move the project forward.

The Business Director concluded his report by saying that many projects are getting underway in the County.

Board member Ms. Alfreda Jarrett Reynolds asked the Business Director what was the role of the IDA with the hiring of staff at Echo World. The Business Director said the IDA did not have a specific role but was assisting Echo World with the staffing. Ms. Reynolds said she had several resources in the medical field and would forward that information to the Business Director to aid in staffing needs at Echo World.
