# **Funding Sources:**

The IDA does have a limited revenue stream and it is vital to protect those resources while at the same time spending dollars to move our action plan forward. We have endeavored to create revenue streams to support our operations. We also will sell completed projects to refill our capital funds for the next project. We received no additional tax dollars during 2019\ 2020 fiscal year.

Other Resources:

• Timber that can be managed-current value on land owned by the IDA is estimated at \$250,000. (St. Pauls)

• Tax Credits for Historic Building Renovation-

1. Because of the National Register of Historic Places designation and the Historic Overlay District in the Town of Lawrenceville we have the ability to access Historic Tax Credits. Lawrenceville is working with us.

• Opportunity Zone - We are working to understand what funds are available and under what circumstances.

• Grant Writer- We are working with Southside Planning District in the arena of grant writing.

• Grants we have received 350,000 from TRRC & VHDA

# A. Property/Land Management. Timber Status

Mr. Will Ford distributed copies of a timber sale notice that will be advertised for the harvesting of 90+/- acres of merchantable timber on the St. Paul's tract owned by the IDA.

The IDA Chair said that she feels that she is blessed and privileged to be in the position that she is in now as the Chair of the IDA Board representing the Sturgeon District. The IDA Chair said that she is also on the Board of Directors for the James Solomon Russell – Saint Paul's College Museum and Archives. She went on to say that she started as a volunteer on the committee to get the museum organized, and the committee became the Board of Directors. She said that recently because of a project the IDA is working on, Paige Pollard with Commonwealth Preservation Group located a grant that the museum would be eligible for that will benefit St. Paul's College.

The Business Director said that the grant for the museum will include a verbal history. It will allow citizens to record their history of St. Paul's College.

The IDA Chair mentioned that she had a chance to re-read James Solomon Russell's Autobiography and she was amazed at how much he had done for the County.
